

Invitation to compete in 2026 European Senior Championships To be organized on behalf of Badminton Europe by Italian Badminton Federation

Badminton Europe would like to invite you to compete in the 2026 European Senior Championships to be held from 19 to 27 September 2026 in Cagliari, Sardinia, Italy.

Badminton Europe and the Italian Badminton Federation invite all Badminton Europe Members to send their Senior players to compete in the 2026 European Senior Championships.

Key dates

- 14 July 2026 Closing date for entries for the 2026 European Senior Championships.
- 7 August 2026 Deadline for Accommodation.
- 21 August 2026 Deadline for Visa, transport and accreditation requests.
- 25 August 2026 Provisional seeding will be published.
- 28 August 2026 Final seeding will be published.
- 31 August 2026 Withdrawal deadline without penalty.
- 1 September 2026 Draws will be conducted and published.
- 1 September 2026 Deadline to nominate team manager / representative.
- 4 September 2026 Deadline for booking practice courts.
- 18 September 2026 Team Managers' Meeting – at 17.00.

2. Entry Details

Regulations	The Tournament will be played in accordance with the Badminton Europe regulations as laid down in App. IX - European Senior Championships and the Laws and Regulations as adopted by the Badminton World Federation. Regulations CLICK HERE
Tournament software	2026 European Senior Championships
Participation Fee	Player entered in: • 1 event: Euro 90, - • 2 events: Euro 120, - • 3 events: Euro 150, - The entry fees are payable after receipt of the invoice. Each Player will receive accreditation and a commemorative towel.

Entries

All 5 events will be played at the Championships in the following age groups: 35+/40+/45+/50+/55+/60+/65+/70+/75+/80+

A player is eligible to compete, provided he or she fulfils the age requirement before 1 January of the year in which the Championships are played. (youngest players must be born in 1990 or earlier).

A player is eligible to enter an event for players younger than the age group he or she qualifies to play in. He or she may, however, not play in the same event in more than one age group.

Each Member shall be entitled to enter in each age group:

8 players in men's singles

8 players in women's singles

A maximum of 16 players in each doubles event (men's doubles, women's doubles and mixed doubles).

A Member may enter a maximum of eight pairs comprising only their own players. However, a Member may enter a maximum of sixteen pairs comprising one of their players partnering a player from another Member, provided always that the total number of players from any Member does not exceed sixteen players in any event. Entries may be submitted only by a Member.

The minimum entry in each event will be 8 players/pairs. Any event not having an entry of 8 players/pairs may be put together with the age group below.

Each Member entering players shall, at least fourteen days before the start of the tournament, nominate their team manager/representative. (When a country only enters one player, that player will be accepted as team manager).

Partnerships will be made after the entry deadline by drawing lots amongst all players entered as "partner wanted".

3. Tournament Details

Seeding Date	Seeding shall be done by Badminton Europe who shall seek expert advice. The provisional seeding will be announced on 25 August 2026 . The final seeding will be announced on 28 August 2026 .
Draw Date	The draw will be conducted and published on 1 September 2026 .
Shuttles	YONEX AS-50.
Practice	An online practice booking form will be made available on the BEC event's website and should be done before 4 September 2026 .
Stringing	Badminton Europe's official event partner and equipment supplier, YONEX, will provide stringing service throughout the whole event.
Team managers Meetings	The Team Managers' Meeting (TMM) will be conducted the day before the start of the tournament at 17:00 at one of the official hotels. Further information regarding the venue will be provided after the close of entries. All participating Members must have a representative present at the meeting.
Technical Official briefing	The Technical Officials' Briefing will be conducted the day before the start of the tournament at 20:00 at one of the official hotels. Further information regarding the venue will be provided after the close of entries.
Medal ceremonies	All medals will be presented on 27 September 2026 after all finals have concluded. All medalists are required to be present at the medal ceremonies.
Catering	A players' area will be available, where catering and beverages can be ordered on a daily basis, no ordering in advance is required. Each day, two meal options will be available, including a vegetarian option. The price is €15 per meal.

Accreditations	Contact e-mail: eurobadmintonca2026@gmail.com Accreditation form can be found online on the tournament website, which must be filled out, and sent to the contact e-mail. Accreditations will be issued at the tournament office in the main venue Both players, coaches, supervisors, and anyone staying will receive accreditation. The deadline for accreditations requests is <u>21 August 2026</u>.
Clothing and advertising	Clothing and advertising will be permitted in accordance with the regulations for the European Senior Championships, regulations 11-12. Please note clothing must comply with existing BWF regulations, unless exceptions have been given by Badminton Europe. In order to ensure an attractive presentation of badminton, only acceptable badminton sports clothing will be permitted during play. A player who wears shoes that leave markings on a badminton court and is not willing or able to change to acceptable shoes, is not allowed to play his/her match. This will be decided by the Referee immediately before the start of the match and consequently the player will be disqualified for this event. The player can still play other events he/she entered. The name of the player and the name of the player's association on the back of the shirt are both optional. In applying regulations on clothing and designs and advertising on players' clothing the decision of the Referee shall be final.
Badminton Integrity	Section 2.4 of the BWF Statutes (Code on The Prevention of The Manipulation of Competitions) relates to anti-corruption and anti-match manipulation, and this code applies to all participants at this tournament.

	To protect the integrity of BWF sanctioned tournaments, participants are not allowed to bet in any way on badminton matches, shall respect the principle of fair play, and shall not attempt to influence the course or result of a game or match. Every person has an obligation to report to the BWF any approaches by anyone to gather inside information or to change the outcome of a match(es). Doping control	Doping control in badminton, in accordance with BWF Anti-Doping Regulations, is conducted out-of-competition and in-competition with the collection of urine and/or blood samples. Athletes are responsible for any substance found in their body. Before an athlete takes any medication, they should check with their doctor, and if necessary, get a Therapeutic Use Exemption (TUE). Cancellation policies

- The confirmatory deposit is in no case refundable.

- From July 16th to August 14th, a reduction of up to 10% of the total number of room nights will be allowed without penalty, any exceeding reduction charged at 100%.
